Turabian Style Documentation

The following guide lists examples for citing books, articles in periodicals and magazines, reference books, and newspapers in standard and online formats according to the 6th edition of Kate Turabian's *A Manual for Writers of Term Papers, Theses, and Dissertations* (**Ready Reference 808.02 T929 1996**).

Basic rules:

- Formatting the Paper
 - double spaced, with the exception of indented block quotations (14.5)
 - \circ margin of at least on inch on all four edges of the page (14.2)
 - a separate title page typically includes the title of the paper, the course, the date, and the student's name (1.7)
 - **indented block quotations** (5.4)
 - block quotations are used for quotes of two or more sentences that take up eight or more lines of text
 - these are single spaced
 - indent four spaces from the left margin of the paragraph
 - if the start of the block quote is also the start of a paragraph in the source, indent the first line 4 additional spaces, for a total of 8 spaces
 - Do not use quotation marks around the block quotation. If what you're quoting has a quote within it, use double quotation marks for that part of the quote.
 - check with your professor for font style, font size, and border size requirements relating to your assignment

• Works Cited Page

- single spaced, leaving a blank line between entries
- o arrange the items alphabetically by author, interfiling books, articles, etc.
- indent the second and following lines of each entry 5 spaces on the Works Cited page
- \circ if no author is given, start with the title and then the date
- when citing websites, include the date the page was created (or updated) and the date you looked at it
- \circ $\;$ The first time a source is referenced, include the full citation.
- If you cite a source listed in the preceding footnote, you may use "Ibid." If the new citation is from the same page as the previous, "Ibid." is sufficient. Otherwise, include the page number (Ibid., 68).

• Footnotes

- should be single spaced, leaving a blank line between entries
- indent the first line of each footnote 5 spaces
- For documents and situations not listed here, see the printed version of the manual.
